

GENERAL RULES FOR THE PAI GOW HIGH HAND GIVEAWAY

1. The “PAI GOW HIGH HAND GIVEAWAY – Promotion” (hereinafter the “Promotion”) refers to the events occurring in the pit area of the Golden Nugget Las Vegas in Las Vegas, Nevada and Golden Nugget Laughlin in Laughlin, Nevada, (hereinafter the “Properties”) on all eligible Pai Gow games, beginning on December 15, 2024 and ending on December 22, 2024.
2. The Properties reserve the right to refuse anyone entry into the Promotion, in its sole and absolute discretion.
3. The Promotion is limited to participants 21 years of age or older with proof of age that the Properties, acting in their sole and absolute discretion, deem appropriate.
4. Individuals must have an active 24k Club Card to participate.
5. The Promotion is subject to all applicable federal, state, and local laws and regulations, including gaming, and all aspects of the Promotion are subject to the approval of appropriate regulatory authorities.
6. Winners must show their valid picture identification (driver’s license, state identification card, or military identification card) in order to collect prize. If winner is not a U.S. citizen, a current passport is required.
7. Winners agree to grant the Properties unconditional use of their name and likeness for promotions/advertising and announcements without compensation, consideration, notice review, or further consent.
8. Winners are responsible for any and all taxes, licenses, registrations and other fees.
9. All tax laws foreign and domestic apply. Winners must show a valid ID to collect winnings. Residents of foreign countries without a U.S. tax treaty may be subject to withholding.
10. Winnings may be subject to reporting and withholding pursuant to Federal IRS regulations, and participants are required to cooperate with the Properties in completing necessary forms, such as a W-9, W-2G or 1042-S.
11. All decisions regarding the interpretation of the rules, eligibility, scheduling and staging of the Promotion, and penalties for misconduct lie solely with the Properties, whose decisions are final.
12. The Properties may cancel, modify, or reschedule any portion of the Promotion at any time without prior notice, except for notification that may be required to be given to the appropriate gaming regulators pursuant to applicable law or regulation.
13. The Properties may disqualify any person for any prize based upon fraud, dishonesty, violation of the official rules or other misconduct while on the property or otherwise occurring whether or not relating to the Promotion or as otherwise reasonable or necessary for the Properties to comply with applicable statutes and regulations, in its sole and absolute discretion.
14. The Properties are not responsible for injuries or losses arising or resulting from participation in the Promotion and are not liable for any acts or omissions by employees, whether negligent or willful, in the conduct of the Promotion, and is not liable in the event of any equipment or software malfunction.
15. The Properties are not responsible for electronic transmission errors or delays resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or

destruction or unauthorized access to or alterations of entry materials, or for technical, hardware, software, or telephone failures of any kind, lost or unavailable connections, fraud, incomplete, garbled, or delayed computer transmissions, whether caused by the Properties, users, or by any of the equipment or programming associated with or utilized in the Promotion or by any technical or human error which may occur in the processing of submissions which may limit, restrict, or prevent a participant's ability to participate in the Promotion.

16. If for any reason the Promotion is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes within or beyond the control of the Properties which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Promotion, the Properties reserve the right at its sole discretion to cancel, terminate, modify or suspend the Promotion
17. Any attempt by any person to deliberately damage any program or to undermine the legitimate operation of the Promotion may be a violation of criminal and civil laws and should such an attempt be made, the Properties reserve the right to seek damages from any such person to the fullest extent of the law.
18. Prizes are non-transferable.
19. Individuals who are excluded from the Properties, either through a government program or by their own request, are not eligible.
20. Employees of the Properties are not eligible to participate.
21. By participation in the Promotion, participants agree to comply with all rules contained herein.

PROMOTION SPECIFIC RULES:

22. Eligible players are those who are being actively rated with their 24k card at eligible Pai Gow games at the Properties.
23. Standard Golden Nugget Pai Gow Poker rules and Table Game House Rules apply.
24. Holding seats is not permitted. If a player is gone from the table for more than 20 minutes, their chips will be taken to the cage and put on deposit.
25. High Hand promotion will start at 12pm on Sunday, December 15 and conclude on Sunday, December 22 at 8pm.
26. Hands will be recorded on a shared spreadsheet between both properties. Current High Hand will be displayed in the pit and updated as it changes.
27. The player who achieves the highest hand during the qualification period will win the prize of \$174,655.05. In the event of a tie, the prize will be split amongst all players who achieved the highest hand.
 - 27.1. A 7 card straight flush with no Joker is the highest achievable hand. This is followed by a 7 card straight flush with the joker. Normal poker card hand rankings apply for four of a kind or below including the kicker.
 - 27.2. Poker Hand Rankings for PG
 - A. 7 Card Straight Flush No Joker
 - B. 7 Card Straight Flush with a Joker

- C. 5 Aces
- D. Straight Flush
- E. 4 of a Kind
- F. Full House
- G. Flush
- H. Straight
 - a. A 2 3 4 5 is the second Highest straight behind A K Q J 10
- I. 3 of a Kind
- J. Two Pair
- K. Pair
- L. High Card

- 28. A waitlist will be used if there are no available seats. Players will receive a text that their seat is available and have 10 minutes to sit down before we move to the next person.
- 29. Only 1 hand is allowed per player. If applicable, Dragon hand is not available for this promotion.
- 30. Players cannot give their seat to another person. If a player, if decides to leave the table, the open seat will go to the waitlist.
- 31. All players are subject to the posted limits and game requirements as displayed on the table sign. Table minimum to be determined by management.
- 32. On Sunday, December 22 at 8pm the promotion will conclude and the player who achieved the high hand will be contacted via phone/email. Winner has 72 hours to respond to attempts to contact or prize will be awarded to the 2nd highest hand achieved.
- 33. Prize can be collected at the end of the promotion. Winner will have 30 days to collect their prize or prize will be awarded to the 2nd highest hand achieved.
- 34. If the winning player fails to produce a valid form of identification the award will be held at the cage until the player can produce valid identification up to 30 days. If the player is unable to produce a valid form of identification by the end of the 30 day period, the prize will be awarded to the 2nd highest achieved hand.
- 35. All irregularities/errors will be handled in accordance with Golden Nugget Policy and Procedures.
- 36. All disputes must be handled at the table at the time of the incident. Once another hand is dealt, all decisions are final.
- 37. Any dispute that is not covered by these rules will be resolved by Golden Nugget Management and all decisions are final.
