

General Rules for All Promotions

General Rules for All Promotions

- 1. Rules for participation and eligibility to participate in Golden Nugget Danville promotions, events, and programs:
 - Must be 21 years of age or older.
 - Must not be state-excluded or property evicted.
 - Must provide accurate information.
 - Remain subject to review and verification.
 - Be responsible for applicable taxes and fees.
- 2. Refusal to abide by these rules may result in, but is not limited to:
 - Disqualification from the promotion/event
 - Forfeiture of prizes
 - Eviction from the property
- 3. Participation in any Golden Nugget Danville promotion, event or program is an agreement to abide by the rules of the program and is subject to the terms and conditions of the Golden Nugget Danville membership and is subject to review and verification.
- 4. Promotional invitations, entries, prizes, and gifts must be accepted as awarded. Are non-transferable and non-refundable.
- 5. Golden Nugget Danville will not be responsible for the loss, theft, mutilation, or illegibility of any part of any offer, scratch card, prize voucher, entry, affidavit, comp, gift card, gift, or any unused or abandoned Free Slot Play offers. Replacement or re-issuance is limited to Golden Nugget Danville management discretion.
- 6. Golden Nugget Danville assumes no responsibility or liability for incorrect information in the database, late arriving or misdirected mail, failure to pick up mail, or any consequential damages arising therefrom, including but not limited to forfeiture of prizes.

- 7. Invitations, coupons, and all other promotional materials are subject to verification and are void if tampered with in any way, incomplete, illegible, mutilated, or if any material contains mechanical, typographical, printing, or any other errors or if any entry is obtained by unauthorized means.
- 8. Golden Nugget Danville is not responsible for a patron's inability to participate in a promotion, event, or program for any reason.
- 9. If a selected participant is unable to participate in the promotion for reasons of physical or mental disability, that person may designate a family member or other person who is over the age of 21 and is immediately present as a surrogate to complete the portion of the promotion on the participant's behalf. Any surrogate so designated is not considered the winner but rather solely the agent of the selected participant. Any and all prizes won by the surrogate will go to the selected participant/winner. Participating in the game portion as a surrogate does not preclude that person from independent participation in the promotion. Both the patron and surrogate must be present. The Marketing Representative will determine if this rule may be invoked in any case.
- 10. A valid club card and a valid government-issued photo ID may be required to participate in promotions, events, and programs. If patrons do not have their valid photo ID, management reserves the right to allow them 72 hours to provide it.
- 11. Promotion winners may be required to complete the promotional paperwork. Refusal to sign or complete the winner's paperwork will result in a prize not being awarded.
- 12. Additional names may be selected if any selected winner is ineligible. See rule 1 for eligibility.
- 13. Acceptance of an offer or prize constitutes the patron's permission to use his/her likeness or name for publicity or promotional uses without compensation.
- 14. Team members of Golden Nugget Danville are ineligible to participate in promotions, events, and programs.
- 15. Immediate family members of Golden Nugget Danville employees (defined as spouse, parents, children, siblings, and their respective spouses) and members of the household (defined as living in the same residence) of Golden Nugget Danville employees are ineligible to claim prizes of \$600 or more.
- 16. Employees of the Golden Nugget Danville Corporate Office, their respective parent companies, affiliates, subsidiaries, advertising and promotion agencies, and other coordinating agencies are ineligible to participate in promotions, events, and programs.
- 17. In no event shall Golden Nugget Danville, its parents, partners, and affiliated companies, their respective agents, employees, directors, officers and legal advisors, and any other companies participating in the design, administration, or fulfillment of this program, be liable

for personal injuries, death, damages, expenses, costs, or losses of any kind resulting from participation or inability to use an award or parts thereof including, without limitation, claims, suits, injuries, losses and damages related to personal injuries, death, damage to or destruction of property, rights of publicity or privacy, defamation or portrayal in a false light (whether intentional or unintentional), whether under a theory of contract, tort (including negligence), warranty or other theory.

- 18. Golden Nugget Danville will not be held responsible for any errors or omissions to any advertising material for any promotion, event, or program, including but not limited to fliers, mail, signs, website, billboards, newspapers, spoken advertisement, recorded advertisement, social and digital media.
- 19. Golden Nugget Danville shall not be held responsible or liable for promotions, events, and programs that are interfered with or are impractical to conduct or continue to conduct in whole or in part as a result of a power failure, explosion, fire, acts of God, civil commotion, labor unrest such as strikes, slow-downs, lockouts, picketing, or boycotts.
- 20. If the equipment used in the operation of this promotion, program, or event malfunctions and becomes inoperable for any reason, the promotion may be suspended until the system is returned to normal operations. Golden Nugget Danville reserves the right to continue the promotion with manual or other automated backup equipment if the equipment is deemed unrepairable. If manual or other automated means are not available or feasible, the Golden Nugget reserves the right to discontinue the promotion, program, or event entirely.
- 21. The Golden Nugget Danville reserves the right to delay or reschedule official drawing times for any promotion due to unforeseen circumstances, including but not limited to technical issues, staffing concerns, weather conditions, or other operational challenges. All efforts will be made to conduct the drawing as close to the scheduled time as possible.
- 22. The Golden Nugget Danville reserves the right to modify, expand, or relocate promotional areas at any time to accommodate business demands, operational needs, or customer traffic. These changes may be made without prior notice to ensure the best possible experience for our guests.
- 23. Golden Nugget Danville promotions, events, and programs are subject to all applicable federal, state, and local laws, including the Illinois Gambling Act.
- 24. Promotions, events, and programs can be canceled or adjusted without notice at Golden Nugget Danville's discretion and with the approval of the Illinois Gaming Board.
- 25. The times stated for promotions, events, and programs are approximate and local to Danville, Illinois.
- 26. If a promotional prize is awarded in error, it must be forfeited and entirely returned in the condition it was originally awarded.

- 27. Golden Nugget Danville management will resolve Any dispute or situation not covered by the above rules in a manner deemed the fairest to all concerned. The decision shall be final and binding for all participants. IGB will be notified of all disputes and their subsequent resolution.
- 28. All Free Slot Play prizes of \$500 or less are valid until the end of the current gaming day.
- 29. All Free Slot Play prizes of \$501 \$2,500 will be valid for three (3) days.
- 30. All Free Slot Play prizes of \$2,501 \$10,000 will be valid for seven (7) gaming days.
- 31. All Free Slot Play prizes of \$10,001 or higher will be valid for fourteen (14) gaming days.
