

Slap Shot Scratchers – Score the Goal of up to Million Points September 2, 9, 16, 23, 30, 2023 OFFICIAL RULES

HOW TO ENTER:

- 1. All Players Club Members may participate.
- 2. Earn 300 base points on Saturdays from 12:01am 12:00pm, beginning September 2, 9, 16, 23, 30, 2023, to qualify to play our Slap Shot Scratchers Kiosk Game. Earn 600 base points to play a second time and 900 base points to play three times. (Play a maximum of three times each promotional day).
- 3. Vouchers may only be printed the day of the promotion.

HOW TO PLAY:
